REGULATIONS

ON THE NATIONAL REPRESENTATIVES OF THE VI INTERNATIONAL COMPETITION ON MANAGEMENT FOR YOUTH INTERNATIONAL ORGANIZING COMMITTEE

(2019)

1. General conditions

- 1.1. The Institute of National representatives of International competition at management for youth International Organizing Committee (hereinafter National representatives) is introduced in order to significantly reduce the cost of the Competition, as well as to create favorable conditions for young people from different countries and continents, who want to participate in the Competition.
- 1.2. The National representatives in the performance of their duties guided by the laws of their countries, the Regulation on the International competition at management of youth, the Regulation on the national representatives, Methodical materials on the Competition, as well as instructions and explanations of the International Organizing Committee.

2. The procedure for the appointment of National Representatives

- 2.1. The National representatives shall be appointed by the International Organizing Committee in each country, expressed a wish to participate in Competition.
- 2.2. The candidates for the status of national representatives are recommended by national organizations in the field of management, business excellence, quality.

Personnel certification bodies, of working in the country, may also recommend candidates for the status of National representatives.

Allowed self-nomination for the status of National representatives as an exception.

Form for Proposals of National representatives provided in Appendix 1.

- 2.3. By decision of the International Organizing Committee may be assigned more than one national representative in one country.
- 2.4. National representatives of the participating countries after the adoption of the International Organizing Committee granted the status of a member of the International Organizing Committee.

3. Basic requirements for candidates for the status of national representatives

- 3.1. A candidate for the status of national representatives should have a university degree and at least two years of practical experience of organizational work.
- 3.2. A candidate for the status of national representative must be a supporter of the sustainable development, business excellence and quality ideas.
- 3.3. When appointing a representative of the National representative benefits have professionals with experience in the field of management, business excellence, or quality.

4. The main functions of National representatives

- 4.1. National representatives have the following main functions:
- promotion of the business excellence and quality ideas in their home countries;
- involvement of young people in their countries to participate in the Competition;
- organization of the Competition in their home countries at the university (organizations) level and at the national level, as well as summarizing its results;

- communicating of the information on the results of competition in their home countries at the university (organizations) and national levels to the International Organizing Committee;
- nomination of Competition participants at the international level from their countries and communicating information about them to the International Organizing Committee (corresponding form provided in Appendix 2);
- organization of the Competition at the international level in their home countries;
- bring to the attention of the participant's information about the results of its Competition at the International level and the organization of their respective awarding by diplomas and certificates;
- implementation of communication and cooperation with the International Organizing Committee.

5. Interaction of National representatives with interested parties

- 5.1. Expert Council of the International Jury sends by e-mail to all National Representatives of the participating countries Methodical materials. Methodical materials contain a description of the Competition nominations, as well as the possible types of individual and team competitions and sample questions.
- 5.2. National Representatives organize the Competition at the university level (organizations) in accordance with the Methodical materials. Universities (organization) hold competitions at their level, awarded the Winners, Laureates and Finalists and recommend them as the participants of the Competitions at the national level to National Representatives of their countries.
- 5.3. National Representatives hold the Competitions at the national level in their own countries using the methodological materials organize the awarding of the Winners, Laureates and Finalists, bring rewarding results to the public in their own countries, including through awareness through the media. Winners, Laureates and Finalists of the Competition at the national level are recommended by the National representatives to Competition at the International level, the corresponding form provided in Appendix 2.
- 5.4. On the eve of the Competition at the International level, Expert Council of the International Jury sends by e-mail to all National Representatives in the countries participants of the Competitions test questions for the corresponding nominations in Russian and / or English. National Representatives, if necessary, arrange for their translation into local languages.
- 5.5. On the day of the Competition National Representatives organize testing of participants from their own country (internally or using the

software and the Internet). The Competition can be held in different countries on different days, agreed with the International Organizing Committee.

- 5.6. The test results of each participant are issued in a form (Appendix 3), which are signed by the participant and the National Representative.
- 5.7. National Representative organizes scan of the signed form and their e-mail transfer to the International Organizing Committee (e-mail: osp@uaq.org.ua).
- 5.8. Within two weeks after receiving the test results from the National Representatives, the International Jury with the involvement of the Expert Council conducts evaluation, summarizes and draws certificates of the Participants, Diplomas to the Finalists, Laureates and Winners of the Competition, which is sent electronically to National Representatives of the participating countries.
- 5.9. After receiving of certificates and diplomas, National Representatives organize their handing in their own countries in a festive atmosphere.
- 5.10. The National Representatives shall bring rewarding results to the public in their own countries, including by means of awareness through the media.
- 5.11. National Representatives sent information on the award in their respective countries to the International Organizing Committee for the generalization.
