# REGULATIONS for the VI International Competition on management for youth

(2019)

#### 1. General conditions

- 1.1. VI International competition on management for youth (hereinafter the Competition) is conducted in accordance with the decision of the International Quality Professionals Guild (IQPG) and Quality Leaders Club of the Central and Eastern European Countries (QLC CEEC).
- 1.2. The Competition is held within the framework of the Global Project "Youth creative movement "QUALITY RELAY RACE".

#### 2. The purpose and objectives of the Competition

- 2.1. The purpose of Competition is to involve young people in the movement for business excellence and quality.
  - 2.2. The main Competitions objectives:

- training, identifying and encouraging young professionals with knowledge and skills to enable them to promote sustainable development of their countries and enhance the quality of life;
- motivation to increase knowledge of young professionals in the field of management, in particular, knowledge and understanding of the requirements of international standards ISO 9000 and other standards, concepts, models and methods of management;
- the development in young people the ability to apply knowledge in the field of business excellence and quality in practice, as well as transfer it to their colleagues among the younger generation of specialists in the field of management;
- development of cooperation between young professionals in the field of quality management, both within countries and at the international level;
- education of young people in the spirit of democracy, partnership, capacity for teamwork and ethical attitude towards society and the environment:
- preparing for an exam to confirm the qualification of the manager on the target management system (in accordance with international standards);
  - identification of role models.

#### 3. Nominations of Competition

- 3.1. The competition is held in a number of nominations, including classified by:
  - types of management systems;
  - types of competitions;
  - the age of the participants.
  - 3.2. There are following main category Competition.
  - 3.2.1. In terms of management systems types:
  - on practices and methods of management;
  - by target management systems based on standards:
  - Quality Management System (ISO 9000);
  - Environmental Management System (ISO 14000);
  - Management System of Health and Occupational Safety (ISO 45000);
  - Energy Management System (ISO 50000);
- Integrated Management System (ISO 9000, ISO 14000, ISO 45000, and others.);
- on management systems, based on the concepts and models of excellence (primarily EFQM model).
  - 3.2.2. In terms of types of competitions:
  - Individual (written and oral examinations);

- Team.
- 3.2.3. In terms of the age of the participants:
- up to 18 years;
- from 18 to 35 years.

#### 4. Levels and date of the Competition

- 4.1. The competition is held on the following levels:
- University (organization);
- National:
- International;
- Full-time Competition Grand Prix for the winners of International competitions in the categories.
- Note: 1. It is expected that in subsequent years the levels of the Competition can be extended: the level of the Continents; the Global level.
- Note 2: In 2019, the decision of the national organizing committee is allowed to install in the country other levels of the competition. At the same time at the international level must be submitted within the period prescribed by this present Regulation.
- Note 3. Winners of the International Competition in nominations take part in the Grand Prix. If there is no winner in some certain nominations in some country, participation in the Grand Prix is allowed for the Laureates or Finalists in the appropriate nominations from this country.
- 4.2. At the university (organizations) level the results of competitions held until April 5 of this year.
- 4.3. At the national level the results of the competitions are held until April 20 of this year.
- 4.4. At the international level, the competition is held online. Since in different countries the training of students ends at different times, the Competition at the international level is held at different times in different countries in the period from April 20 to October 20.
- 4.5. Grand Prix for the winner of international competitions in nominations held at a time and place determined by the International Olympic Organizing Committee, usually in November (during the World Quality Day).

## 5. Organizers of the competition and organization of its implementation

- 5.1. The Competition is held by the International Guild of Quality Professionals and Quality Leaders Club of the Central and Eastern Europe with the assistance of Ukrainian Association for Excellence and Quality (UAEQ).
- 5.2. The main organizer of the competition at the international level is the International Organizing Committee of VI International Competition on management for youth (hereinafter the International Organizing Committee), comprising National Representatives of all countries, participating in the Competition.

Leader of the Global Project "Youth Creative Movement "Quality Relay Race" is designated as the Chairman of the International Organizing Committee.

5.3. Overall scientific guidance of the Competition provides International Jury of the VI International Competition on management for youth (hereinafter - the International Jury), consisting of the most famous and recognized scientists and experts in the field of modern management system.

President of the International Guild of Quality Professionals is appointed as the Chairman of the International Jury.

- 5.4. The International Jury creates Expert Council from specialists with theoretical and practical experience in the development, implementation, application and / or improvement of management systems for preparation of the issues and direct evaluation of Competition's results at the international level. Head of the Expert Council is a member of the International Jury.
- 5.5. The general management of the Competitions organization and holding at the national level (the level of countries) is carried out by National Representatives of the International Organizing Committee of and headed by them National Organizing Committees.
- 5.6. It is advisable to carry out the Competition at the national level under the auspices of national quality organizations and national enforcement authorities in the field of education.
- 5.7. It is recommended to widely involve personnel certification bodes, operating in the country, to carrying out of the Competitions.
- 5.8. Organizing Committees, which are created in the universities (organizations), ensure conducting of the Competition in these universities (organizations).

- 5.9. The universities (organizations) has created the Expert Councils from specialists with experience in the development, implementation, application and / or the improvement of management systems at respective Organizing Committee for the preparation of relevant questions, and direct evaluation of the Competition results at national level and the level of universities (organizations). Heads of Expert Councils are members of the respective Organizing Committees.
- 5.10. The information about the intention of the Competition at the level of the university (organization) is sent to the National Representatives in the respective countries participants.
- 5.11. National Representatives reported to the International Organizing Committee on the outcome of Competitions at the university (organizations) level and at the national level in their countries.

#### 6. Methodical materials for Competition conducting and summarizing

- 6.1. General methodological materials for all levels of the Competition developing the Expert Council of the International Jury.
- 6.2. International Jury approves general methodological materials for all levels of the Competition and sends it to National Representatives in the countries participants.
- 6.3. The Expert Council of the International Jury develops questions for the Competition at the international level.
- 6.4. Expert Councils of university (organizations) Organizing Committees develops questions for the Competition of the respective level.

#### 7. Participants of the Competitions

- 7.1. Schoolchildren, students, university graduates, professionals and graduate students under the age of 35 years old can participate in the Competition.
- 7.2. To participate in the Competitions on an international level, the applicants submit the application to the Organizing Committee in the form, set out in Annex 3, no later than April 25 of this year.
  - 7.3. The application included a request of the Jury at the national level.
- Note: 1. If the national-level Competition is not carried out, the application included a request of university (organization) Jury of applicant.
- Note 2: If the Competition was not carried out also at the university (organization) level, the recommendation of the university (organization) management can be attached.

#### 8. Summarizing of the Competition.

- 8.1. Organizing Committees of the universities (organizations) carry out the summarizing of the Competition (determination of Winners, Laureates and Finalists) at the university (organizations) level.
- 8.2. Organizing Committees of the respective countries carry out the summarizing of the Competition (determination of Winners, Laureates and Finalists) at the level of their countries.
- 8.3. International Jury carries out the summarizing of the Competition (determination of Winners, Laureates and Finalists) at the international level.
- 8.4. International Jury carries out summarizing of the results of the International Competition Grand Prix. (determination of Winners, Laureates and Finalists).

#### 9. Awarding of the Competitions Winners, Laureates and Finalists

- 9.1. Appropriate Organizing Committees implement awarding at the national level and the university (organizations) level.
  - 9.2. International Jury implements awarding at the international level.
- 9.3. The Winners, Laureates and Finalists at the university (organization) level and at the national level will be awarded Diplomas of corresponding of Organizing Committee.
- 9.3. Rewarding of Winners, Laureates and Finalists of International Competition at the international level are carried out by the International Organizing Committee together with the International jury. The International jury reviews the answers of participants, which sent by the National Representatives in the countries. The Head of the International Jury Expert Council compiles the list of the Prize Winners in nominations and sends them for approval to the Chairman of the International Organizing Committee, as information on the International Competition in the countries is received from the National Representatives of the International Organizing Committee. After the list of winners is approved, they are issued with the appropriate certificates and sent electronically.
- 9.4. The Winners, Laureates and Finalists at the international level will be awarded by Diplomas of International Organizing Committee and International Quality Professionals Guild.
- 9.5. The Winners, Laureates and Finalists of International Competition Grand Prix will be awarded by Diplomas of International Organizing Committee and International Quality Professionals Guild.

Note. As a result of international Competitions International and Grand Prix Jury sends newsletters to universities and central bodies of executive

power on issues of education of the countries in which the participants received the status of Competitions Winners, Laureates and Finalists.
